

SÃO PAULO ENVIRONMENTAL AGREEMENT - INTERNATIONAL OBSERVER

Thank you for your interest in joining as an International Observer of the São Paulo Environmental Agreement, initiative of State Secretariat of Foreign Affairs - SENI, State Secretariat for the Environment, Infrastructure and Logistics - SEMIL and CETESB - Environmental Company of the State of São Paulo, on behalf of the State of São Paulo.

Please read the following Terms of Use carefully and complete the fields on this form.

Adherence is formalized by sending the requested information, described below.

TERMS OF USE

The adherents to the Environmental Agreement of SP (hereinafter referred to as "AGREEMENT") as Observers, will be able to observe the activities and work together with the members of the AGREEMENT.

The invitation to join the São Paulo Environmental Agreement as an Observer is part of the recognition of the State of São Paulo that those guests have important leadership in the environmental area, either for their activism, technical knowledge, tradition of environmental preservation or for their power to mobilize civil society.

1) Parts

The AGREEMENT is signed between the observer and the Government of the State of São Paulo, through SERI – State Secretariat for International Relations, SEMIL – State Secretariat for Environment, Infrastructure and Logistics and CETESB – Environmental Company of the State of São Paulo.

2) Adhesion, renewal, withdrawal and update

Joining the AGREEMENT as an Observer Member is open to a institution or individual, upon invitation, which cumulatively:

- (i) is a natural person or a legally constituted legal entity;
- (ii) is invited by CETESB for their recognized knowledge, leadership and performance in the environmental area;
- (iii) agree with the AGREEMENT's Terms of Use; and,
- (iv) do not violate any rule.

The Government of the State of São Paulo reserves the right to change the eligibility requirements to the AGREEMENT, both annually, as an update, and at any time to remedy any methodological flaws, communicating the changes to its members and requesting ratification.

Membership as an observer member begins with an invitation to join the Chamber of Climate Change, followed up by sending the appropriate information to CETESB, through

the institutional e-mail **atendimento2030_cetesb@sp.gov.br**. Renewal will be automatic until 2030.

The ADHERENT can withdraw from the AGREEMENT at any time, by means of physical or electronic correspondence sent to CETESB (Advisory, Presidency, Av. Professor Frederico Hermann Jr. 345 São Paulo - SP, CEP 05459-900, e-mail **agreement2030_cetesb @ sp.gov.br**), with confirmation of receipt.

CETESB is not responsible for cases of ideological misrepresentation, in which data are sent to the AGREEMENT by individuals not authorized by the MEMBER, in which case adherence, renewal and / or withdrawal will be considered null and void. If it is necessary to complement the data received, or to verify the authenticity of the forms sent, CETESB may contact the person appointed by the ADHERENT at any time.

Requested information: (i) data and contact details of the MEMBER (name, position, e-mail, telephone, cell phone) , in the case of invited individuals; (ii) ADHERENT data and contact details (name, company name) and (iii) data and contact details of the representative indicated by ADHERENT to perform the duties as an international observer of the AGREEMENT (name, position, e-mail, telephone, cell phone), in the case of invited institutions. The invited institutions have the autonomy to choose, within their own organizations, a representative with whom they have a formal link to represent them, as well as the autonomy to freely change this indication, being their responsibility to communicate to CETESB about these changes.

In order to improve the AGREEMENT, the Government of the State of São Paulo may review its guidelines annually, submitting the new terms to the ADHERENT for ratification.

3) Costs

The Government of the State of São Paulo will not charge and does not authorize third parties to charge any type of financial value for joining or staying in the AGREEMENT. The expenses for obtaining the information provided and for its eventual verification or certification must be borne by the ADHERENT.

4) Confidentiality

CETESB will maintain the faithful custody of the information provided, which is not to be confused with that sent to other entities under public or private law, in particular the environmental licensing data at CETESB. CETESB will only disclose voluntary commitments on avoided emissions, compensation, emission reduction and removal of greenhouse gases, with the identification of the ADHERENT.

Additional information that the ADHERENT wants to provide to CETESB can be inserted in a file in PDF format (copy in Excel of information related to GHGs is desirable), sent through the institutional email **agreement2030_cetesb@sp.gov. br**, and must contain express mention if the ADHERENT does not authorize its disclosure.

5) Brand

The AGREEMENT logo is owned by CETESB and can be used by the MEMBERS, provided that they disclose the reference year.
