## Jason Green - Public Affairs Officer



Jason most recently served for two years as Public Affairs Officer (PAO) at the U.S. Consulate General in Karachi, Pakistan, where he oversaw a team of four American officers and sixteen Locally Engaged Staff (LES). Prior to Karachi, he served as Deputy PAO at the U.S. Consulate General in Johannesburg, South Africa. He also served as Special Advisor for High-Level Programs in the Bureau of African Affairs, Office of Public Diplomacy and Public Affairs (AF/PDPA). His primary role in this position was to lead the State Department's coordination of President Obama's Young African Leaders Initiative (YALI), the largest PD program in the Bureau's history. Jason also served as Deputy Cultural Affairs Officer at Embassy Kabul, Cultural Coordinator in AF/PDPA, and Consular Officer at Embassy Tel Aviv. He has received four Superior Honor Awards for his "exceptional leadership under adverse conditions" in Pakistan; for supporting Afghanistan's first-ever democratic transition of executive power; for his work with African Chief Justices, which culminated in the first-ever Presidential Roundtable with African jurists when President Obama visited Dakar, Senegal in 2013; and for "leadership and strategic vision in the implementation of President Obama's Young African Leaders Initiative." Prior to the Foreign Service, Jason was in-house counsel at the Screen Actors Guild in Los Angeles.

David Hodge began his assignment as Consul General in São Paulo on July 13, 2021. He is a member of the Senior Foreign Service and began his diplomatic career 30 years ago, as a Vice Consul in Rio de Janeiro. He served twice at the U.S. Embassy in Brasília.

Before returning to Brazill, he served as Deputy Chief of Mission in Guatemala City and as Chargé d'Affaires in Panama City in 2019. At the State Department, Mr. Hodge was the Director for Public Affairs and Public Diplomacy in the Bureau of Western Hemisphere Affairs and also was an Assessor at the Board of Examiners.

Earlier in his career, Consul General Hodge served as the Counselor for Public Affairs at U.S. Embassies in Bangkok and La Paz, and Cultural Attaché in Brasília and Lima. He was also assigned as Political/Economic Chief in Maputo, Deputy Consul General in Buenos Aires, Political Officer in Lisbon, and Environment, Science, and Technology Attaché in Brasília.


